<u>Civil History Search - County</u>
Civil records will be researched in the applicable jurisdiction(s) to meet the search scope criteria. Civil suits at the county level encompass such matters as small claims disputes, breach of contract and real estate foreclosures.
Civil History Search - Federal
Searches are performed through the Public Access to Court Electronic Records (PACER) system, which allows us to obtain case and docket information from federal appellate, district, and bankruptcy courts. Civils suits at this level include civil rights violations, torts, bankruptcy and civil cases filed at the federal courthouse.
Consent Based Social Security Number Verification (CBSV) \$13.50
This search will verify whether a name, date of birth and social security number (SSN) combination match the data in the Social Security Administration's (SSA) records. If applicable, we will report a death indicator when the search reflects that the SSN holder is deceased.
Credit History \$15.00
Credit reports will be obtained from one or more of the major credit bureaus. These reports identify trade accounts, credit limits, balances, payment history, collection accounts, bankruptcies and tax liens.
Criminal History Search - County/Statewide
A statewide criminal record search will be made in states where a central repository is accessible, and results are available within three (3) to five (5) business days. Alternately, a county criminal record search will be conducted and may be supplemented by an additional search of lower, district or municipal court records.
